FT_PT: FULL-TIME/PART-TIME CRITERIA:

FULL-TIME (FT):

UNDERGRADUATES - 12 or more hours.

GRADUATES: MS-CNSL - 10 or more hours; MSCJ, MMT, or MM - 9 or more hours; MBA - 7 or more hours; MSN, MPS, MRE, MCJ - 6 or more hours; Other Graduates - 9 or more hours.

LAW - all day classifications excluding part-time day classifications; LAW classifications -LWA, TRP, LM1, and LM2 and 13 or more hours.

DOCTORAL - 9 or more hours.

PART-TIME (PT):

CONTINUING EDUCATION (CE) - Based upon Continuing Education Units (CEUs) not credit hours.
