Includes those on sabbatical leave and replacement on leave without pay and Clinic Faculty. Excludes faculty on leave without pay and replacements for instructional faculty on sabbatical leave. Excludes teaching assistants and teaching fellows. Excludes officers such as dean of students, librarian, registrar, coach, etc. whose major regular assignment is not instruction. (Based on AAUP Definition)
Also includes faculty who are on a buyout, phased retirement or reduction in force who are teaching in 2010 Fall.

** Non-Instructional Faculty: Includes those faculty who are on leave without pay, phased retirement, and buyouts for those faculty not teaching 2010 Fall. This is a

** Administrative Faculty: Includes faculty whose major regular assignment is not instruction (assoc. provosts, deans, assoc. deans, etc.)
