* Instructional Faculty: Includes faculty members whose major (more than 50%) regular assignment is instruction, including those with released time for research. Includes those on sabbatical leave and replacements for instructional faculty on leave without pay and Clinic Faculty. Excludes faculty on leave without pay and replacements for instructional faculty on sabbatical leave. Excludes teaching assistants and teaching fellows. Excludes administrative officers such as dean of students, librarian, registrar, coach, etc. whose major regular assignment is not instruction. (Based on AAUP Definition)

Also includes faculty who have a buyout or phased retirement who are teaching in 2007 Fall.

** Non-Instructional Faculty: Includes those faculty who are on leave without pay, phased retirement, buyouts or reduction in force for those faculty not teaching 2006 Fall. This is a holding category.

*** Administrative Faculty: Includes faculty whose major regular assignment is not instruction (assoc. provosts, deans, assoc. deans, etc.)
